
### LOCATION

Trumpington is within Cambridge City Bounds and located approximately 2 miles southwest of Cambridge city centre. Trumpington has great transportation links being situated just off the M11 (junction 11) giving access to the Midlands via the A14 and London.

The local Park and Ride is also an interchange for the new guided bus way which provides a direct, fast connection to Cambridge railway station – which in turn has twice hourly 'fast' train services to London

The immediate surrounding area provides good local amenities including a Waitrose, a post office and 3 pubs.

Addenbrookes Hospital and Cambridge Biomedical Campus are located less than 2 miles from the office – less than 10 minutes on a bike.
